**PCDA(N) ADVISORY No.-04 regarding Pre-16 e-PPO dt. 02/12/2020**

1. Pre 16 Revision was carried out and first batch of 30134 (Thirty Thousand One Hundred and Thirty Four Only) Draft e-PPOs issued on 14.08.2020 and uploaded on NAVPEN website.
2. Dedicated e-mail ID **pcdanavysuomoto.dad@gov.in** was created for the esteemed veterans to address discrepancies, if any. 5000 plus emails were received out of which only 732 mails were actionable and pertained to Pre-16 Revision.
3. Actions on all 732 cases were taken and amended e-PPOs and advisory uploaded on NAVPEN website on 23.10.2020.
4. All the 30134 e-PPOs were sent to concern CPPCs for taking necessary action and to carry out revision of pension w.e.f 01.01.2016.
5. **27127** (Twenty Seven Thousand One Hundred and Twenty Seven only) draft e-PPOs have now been generated and handed over to NAVPEN on 02.12.2020 for uploading on their website.
6. Access has been provided to the esteemed veterans to point out any anomaly/anomalies in their draft PPOs. All requests for amendments/ corrections, duly enclosing the latest corrigendum PPO as a supporting document should reach this office by 15.12.2020.
7. In addition, there are few cases wherein this office is unable to generate Suo-moto PPOs due to non availability of corresponding pay details available in concordance table (cir-608). Such cases are being referred to Pay Accounts Office for fixation of Notional Pay w.e.f 01.01.2016. e-PPOs for such cases as detailed below will be generated subject to notional pay fixation by PAO.(Annexure-A)
8. Stepping down has been carried out by PAO for 2598 cases which is listed below (Annexure-B). Pre-16 Revision for all these cases will be carried out only after completion of stepping down.
9. This being a first initiative by PCDA (Navy) to carry out generating of e-PPOs simultaneously with the digitization process, probability of missing e-PPOs in the second batch cannot be negated. These conditions may be due to non availability of correct information in the database / issuance of manual PPO. Provision has been made in NAVPEN website for esteemed veterans in such cases to provide their details duly supported by original PPO and subsequent corrigendum PPOs to enable this office to generate the Pre-16 e-PPOs.
10. As per PCDA(P) Allahabad circular 585, Pre-16 PPOs has not been generated for Public Sector Undertakings/ Autonomous Body absorbees who have drawn lump sum payment of pro rata pension, whose 43% (in case of Commissioned Officer) and 45% (in case of JCOs/ ORs) pension has been restored.
